REGISTRATION OPEN FOR FALL TESTING PERIOD OF CERTIFIED DIRECTOR OF ASSISTED LIVING EXAM:

Registration is now open for the testing period taking place this fall, September 15 – December 15, for the Certified Director of Assisted Living (CDAL) exam. November 1 marks the registration deadline. Successful completion of the CDAL exam is one of the requirements for attaining certification through the Senior Living Certification Commission. To date, 333 senior living professionals have earned the distinctive credential.
